PRIVACY NOTICE - PUPIL INFORMATION

At Gwaunfarren Primary School we are the Data controller for the purposed of the Data Protection Act. We collect information from you and may receive information about you from your previous school.

The Organisation/Data Controller

Categories of Pupil Information

The categories of Pupil information that we collect, hold and share include:

 \leftrightarrow Personal information - such as name, unique pupil number and address;

↔ Characteristics - such as ethnicity, language, nationality, country of birth and free school meal eligibility;

↔ Attendance Information - such as sessions attended, number of absences and absence reasons;

↔ Assessment and Progress Information - such as teacher assessments, test outcomes, performance data;

 $\leftrightarrow \mathsf{Medical Information} \text{ - such as allergies, dietary needs, medications, health issues}$

↔ Additional Learning Needs (ALN) Information - such as a pupils entitlement to support, School Action, School Action +, Statement;

↔ Behavioural Information – such as exclusions

The purpose for Collecting Personal

Data We use the Pupil data to;

- \leftrightarrow Support pupil learning
- \leftrightarrow Monitor and report on pupil progress
- \leftrightarrow Maintain the safeguarding of pupils at school
- \leftrightarrow Provide appropriate pastoral care
- \leftrightarrow Assess the quality of our services
- \leftrightarrow Comply with the law regarding data sharing

The legal Basis for using Personal Data We collect and use pupil information under two main bases within the school setting;

↔ Basis of Public Interest – where the school, as a Public Body, is able to process data for Public Interest purposes.

 \leftrightarrow Basis of Consent – where permission is given by a Parent for data to be processed, particularly where special category data is concerned.

 \leftrightarrow Basis of Legal Obligation – where processing of data is necessary for us to comply with the law

Collecting Pupil Information

Whilst the majority of pupil information you provide to us is mandatory, some of it is provided to us on a voluntary basis. In order to comply with the General Data Protection Regulation, we will inform you whether you are required to provide certain pupil information to us or if you have a choice in this.

Please note that a consequence of not providing us with certain statutory personal information may affect your child's eligibility to attend the school.

Storing and Retention of Pupil Data

We hold pupil data for the entire time that a pupil is with us at Gwaunfarren Primary School. This information is held for 3 years after a pupil has left Gwaunfarren Primary School (unless the pupil transfers to another school whilst at Gwaunfarren Primary School.)

Recipients of Data

We routinely share pupil information with:

- \leftrightarrow Schools that the pupil's attend after leaving us;
- ↔ Our Local Authority (Merthyr Tydfil CBC)
- ↔ The Department for Education (DfE)
- \leftrightarrow School Nurse
- \leftrightarrow Social Services
- \leftrightarrow NHS
- ↔ Police (School Liason Officer)

Why we share Pupil Information

We do not share information about our pupils with anyone without consent unless the law and our policies allow us to do so.

We share pupil's data with the Department for Education (DfE) on a statutory basis. This data sharing underpins school funding and educational attainment policy and monitoring.

We are required to share information about out pupils with our Local Authority (LA) and the Department for Education (DfE) under The Education (Wales) Regulations 2011, The Pupil Information (Wales) Regulations 2011 and The School Information (Wales) Regulation 2011.

Geographic Location

Your information will not be used outside of the European Economic Area.

Rights of the Individual

Under Data Protection legislation, Parents and Pupils have the right to request access to information about them that we hold. T make a request for your personal information, or be given access to your child's educational information, you will need to submit a 'Subject Access Request' from to the

You also have the right to;

↔ Object to processing of personal data that is likely to cause, or is causing, damage or distress;
↔ Prevent processing for the purpose of direct marketing (which will never be done by the school);
↔ Object to decisions being taken by automated means ↔ In certain circumstances, have
inaccurate personal data rectified, blocked, erased or destroyed; ↔ Withdraw information if it is the
legal basis being used

 \leftrightarrow Claim compensation for damages caused by a breach of the Data Protection regulations
